<u>Limits of Liability</u>: The limits of liability per claim and the annual aggregate vary by levels: faculty, resident/fellow/intern, or student.

Type of Coverage (claims made / occurrence / extended reporting policy or tail): Per Occurrence

Type of Coverage (Individual or Shared): Individual

<u>Dates of Coverage</u>: Coverage for individual participants begins on the date of employment or registration in medical school or on the date of licensure, whichever occurs latest. Coverage ceases for events occurring after the date of employment or after registration with The University of Texas System is terminated.

Professional Liability Insurance ("PLI") Coverage:

Professional Liability Insurance ("PLI") coverage is provided through various sources at the University:

• <u>The University of Texas System Medical Liability Benefit Plan</u>: Self insurance that covers medical and dental faculty and covers residents and fellows during rotations outside Memorial Hermann Hospital-TMC. (See Commercial Insurance below for coverage provided for rotations at MHH-TMC.)

Faculty Limits - \$500,000 per claim / \$1,000,000 annual aggregate
Resident Limits - \$100,000 per claim / \$300,000 annual aggregate (rotations outside MHH)

• <u>Commercial Insurance</u>: A policy provided by Memorial Hermann-TMC for any claims or lawsuits resulting from patient care provided during rotations by medical residents and fellows at Memorial Hermann Hospital-TMC.

Limits – \$100,000 per claim / \$300,000 annual aggregate.

State Indemnification: The State of Texas may provide indemnification from judgment damages to all employees of the State, including all UTHealth employees (e.g., faculty, staff and allied health professionals), and under certain circumstances, to employees of health care entities formally affiliated with a state agency; residents and many fellows are employed by The University of Texas Medical Foundation, a private, nonprofit organization. In general, indemnification may be provided if a judgment is imposed based on an individual's actions in the course of their regular duties, but the individual cannot be found to have acted in bad faith or with gross negligence or conscious indifference.

Limits – \$100,000 per person / \$300,000 per occurrence.

Credentialing Requests to The University of Texas System:

To obtain a written claims history for a physician or dentist, The University of Texas System requires a written request signed by the requesting doctor. Please be sure to state that you authorize The University of Texas System to release your medical liability claims history.
