recently traumatically injured loved one are associated with caregiver depression, anxiety, and substance use at 3 and 6 months following a critical injury to a loved one. The research will then evaluate the effectiveness of traditional, psychotherapy using problem solving therapy to reduce depression, anxiety, and substance use at 3 and 6 months. Finally, the research will then evaluate the effectiveness of providing an ICU diary and instruction on that diary to reduce depression, anxiety,

and substance use at 3 and 6 months.

Summary: The Trauma Recovery Clinic is a hospital-based behavioral health outpatient clinic

specializing in the treatment of psychologic sequelae following traumatic injury.

Patients receive patient-centered, evidence-based interventions and

pharmacological treatments for PTSD and comorbidities in a cross-disciplinary environment. Standardized assessments are completed at intake and weekly follow-up visits. Assessment data and comprehensive chart reviews are used to evaluate TRC clinical and economic outcomes. Summary: The overarching goal of this UH2-UH3 project is to work synergistically with the

NIH HCS Research Collaboratory to efficiently develop and implement an

innovative large scale, pragmatic clinical trial that directly informs national trauma

care system policy. The study is comprised of a 20 trauma center cluster randomized trial that incorporates Collaboratory-informed state-of-the art

assessments and information technology innovations. The intervention aims to prevent the development of chronic PTSD and depressive symptoms, alcohol use problems, and enduring physical disability in survivors of both TBI and non-TBI injuries; the intervention also aims to mitigate the impact of the acute injury event on symptom exacerbations in the large subpopulation of patients who already carry a substantial pre-injury burden of multiple chronic medical conditions. The intervention utilizes a computerized decision support tool to flexibly target 3 chronic conditions and includes care management, medication, and psychotherapy elements.

Summary: This project worked to systematically develop, standardize, and then pilot test

> Virtual Reality Exposure Therapy (VRET) for post-traumatic stress disorder (PTSD) in gunshot victims admitted to the University Medical Center (UMC) in New Orleans. Virtual reality (VR) has been introduced in both civilian and military populations as an augmented form of Prolonged Exposure Therapy to treat PTSD in which the patient is exposed to a VR environment that simulates their traumatic experience rather than relying on their imagination. However, there are no current applications of VR with gunshot wound victims with PTSD. Therefore, we aim to 1) develop a virtual reality environment simulating a gunshot victim's traumatic experience through collaboration between the LSU Geometric & Visual Computing group in School of Electrical Engineering and Computer Science (EECS) and the LSUHSC Department of Psychiatry, 2) adapt a military VRET protocol for use with civilian gunshot victims, and 3) pilot test the intervention with 15 gunshot victims admitted to UMC.
