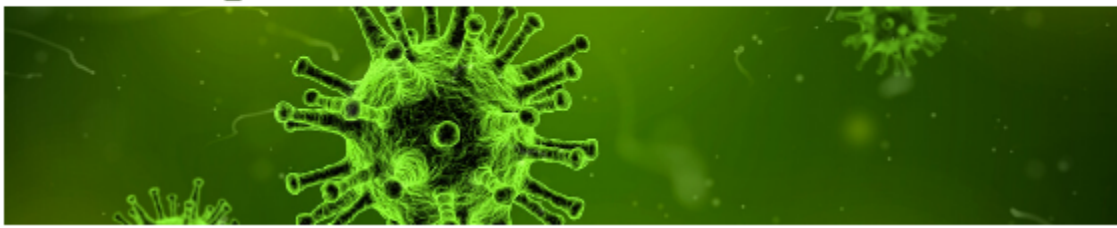

COVID 19 update

- **Safe Passage**

- **COVID Imaging **Updated*** – Please see attached presentation on standardized reporting guidelines for chest imaging in COVID 19 patients by Dr. Ocazonez.
- **Outpatient Consolidation**
The plan for the TMC OPID is the following effective Monday, March 30th – Tuesday, April 21st:
 - Close and Consolidate Upper Kirby OPID into the TMC OPID;
 - Close and Consolidate Bellaire OPID into the TMC OPID; and,
 - Bayshore closing on Monday, March 30 and will consolidate with League City CCC – Section Chiefs can redeploy radiologist scheduled at OPID as needed.

We will be expanding the hours of operations likely in MRI and CT to accommodate the volume needs as well as in the Breast Center for any diagnostic MA follow-up for Pearland as well as TMC BC which will require additional radiologist coverage:

- MRI expanding to 7:30 AM- 10 PM M-F and 7:30AM – 8 PM on **SATURDAY**
- CT will mirror the same hours as above for MRI

- Breast Center will need to expand from 4 days a week to 5 days a week unless we are able to do a consolidation strategy or extend hours of operation with the 4 day a week model.
- US, NM, PET and XR should be able to be handled with the current hours of operation
