As an abdominal transplant surgeon I have over 25 years of clinical experience in solid organ transplantation and complex hepato-biliary surgery. I am multi-organ trained (University of Nebraska Medical Center) with a personal experience of over 2,000 liver transplants including pediatric and split liver transplantation. My career has allowed me to build and lead abdominal transplant teams twice (adult liver/pediatric kidney and liver, abdominal multi-organ). Each time the program was able to achieve outcomes among the best in the country based on risk adjusted patient/graft survival, rates of transplant and survival on waiting list. The current program I lead (Memorial Hermann TMC/McGovern School of Medicine University of Texas Houston) is in the top 10 for one-year survival post-transplant with one of the lowest mortality of waiting list and highest rate of transplantation for the country – SRTR data 01/2020. The kidney transplant program at Memorial Hermann TMC also performs well above expected with one of the best 3 year graft survival as well as the shortest waiting time to transplantation in the state of Texas, SRTR data release 01/2020. In 2019, the kidney transplant program was recognized by UNOS thru the COIIN project (Collaborative Improvement and Innovation Network – (designed to look at best practices to increase the utilization of cadaver kidneys and increase the number of patients transplanted). Each program I have lead is centered on the patient experience by achieving optimal outcomes with respect for the patient and their family. The goal I have always emphasized, to the patient care team, is to become the leader (content expert) in patient care in our area of expertise (abdominal transplantation), setting the standards that other providers seek to emulate and patients wish to have provide their care.
